## NOTES:-

1. Membership season runs from 1<sup>st</sup> March to the end of February each year.
2. New Ordinary Members and/or members changing to Ordinary Membership from a different category are required to pay the Entrance Fee. (For previous Intermediate Members, entrance fees are subject to a reduction of one quarter for every year completed to a maximum of three quarters of the said Entrance Fee ruling at that time).
3. A **new member** joining within the 2011 season will pay a single fee of **£995.00** which includes the entrance fee and subscription. In subsequent years only the annual subscription ruling at that time will be payable.
4. **Family Membership - £1575.00** covers the entrance fees for both adults and subscription for two adults (Ordinary Membership) and their children. Thereafter, the annual subscription equal to that of two Ordinary and one Junior ruling at that time will be due in subsequent years.
5. Age restrictions relate to any persons falling within the limitations **prior to 1<sup>st</sup> January 2011**. For example any girl/boy who attains the age of 11 years after the 1<sup>st</sup> January 2011 will still maintain Cadet membership for 2011.
6. VAT is charged at 20%. VAT No: 260 2690 75
7. Fees are due in advance of the membership year however there is also the option to pay by debit or credit card (a £15 surcharge applies for credit card payments for 2011) or monthly by direct debit through Fairways Credit (this facility incurs a 6.1% surcharge for 2011 for a 10-monthly payment plan).
8. The Proposer and Secunder should be existing Ordinary Members of at least 3 years. If a Proposer or Secunder is not known, please leave blank.
9. Your application form will be available for general view by our members (over 18 yrs old only) and your name and home telephone number will be visible to other members via the Members' Area of our website (no telephone numbers for juniors/cadets will be displayed.).
