THE DIRECT DEBIT GUARANTEE

- 1. This guarantee is offered by all Banks and Building Societies that take part in the Direct Debit scheme. The efficiency and security of the scheme is monitored and protected by your own Bank or Building Society.
2. If the amounts to be paid or the payment dates change, Premium Credit Ltd will notify you five working days in advance of your account being debited or as otherwise agreed.
3. If an error is made by Premium Credit Ltd or your Bank or Building Society, you are guaranteed a full and immediate refund from your bank of the amount paid.
4. You can cancel a Direct Debit at any time by writing to your Bank or Building Society. Please also send a copy of your letter to Premium Credit Ltd.

TERMS & CONDITIONS

- 1. Fairway Credit (FC) agrees to collect from the member on behalf of the member's golf club, payments of fees and other amounts due as agreed from time to time.
2. Any change in the monthly payment will be notified to the member before collection.
3. Any collection of a payment does not imply that membership is in force.
4. If the member: (a) fails to comply with any of the items of this agreement; or (b) fails to make a payment to FC on or within 7 days of the due date for payment; or (c) fails to maintain a direct debit mandate; then and in any such event the member's membership may be suspended by the club with effect from the date on which the event of default has occurred.
5. The golf club is not the agent of FC and FC shall not be liable to the member for any act, default or omission of the golf club.
6. No time or indulgence extended to the member nor any waiver of any breach hereof shall prejudice, affect or restrict the rights and powers of FC.
7. This agreement is personal to the member and is not assignable by the member.
8. The expression "FC" shall include its successors and assigns.
9. The terms and conditions of this agreement will apply to any renewal unless otherwise advised by FC on or before the dates of such renewal.
